Abstract: [Purpose/significance] ALI has important reference to the construction of unified and standardized open metadata elements in China, at the same time, eliminate the author's copyright concerns and balance the interests of all parties, and promotes the standardized development of open access movement in China. [Method/process] It introduces the background, content and application of the implementing practice which is recommended by NISO, as well as its role and impact in the open access information exchange model.
